

2018 Gas for a Year*
Twin Cities Auto Show Sweepstakes Terms and Conditions

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR ODDS OF WINNING.

I. SPONSOR: This sweepstakes (“Sweepstakes”) is sponsored by Northern Tier Retail LLC d/b/a SuperAmerica (“Sponsor”), 576 Bielenberg Drive, Suite 200, Woodbury, MN 55125.

II. ELIGIBILITY: Except as otherwise set forth herein, this Sweepstakes is open to legal residents of Minnesota, Wisconsin and South Dakota who are at least 18 years of age. Employees or officers of Sponsor, Sponsor’s affiliates and Sponsor’s franchisees/licensees, together with members of their households and immediate families (spouses, parents, children, siblings and grandchildren) are not eligible to enter or win. Participants are subject to all applicable federal, state and local laws and regulations. Void where prohibited or restricted by law, rule or regulation.

(the “Entry Period”). Entries not received during the Entry Period are void. Sponsor is not responsible for the cancellation, in whole or in part, or any shortened official hours of the Auto Show.

IV. HOW TO ENTER: Participants may enter the Sweepstakes, in one (1) of three (3) ways:

1. *Via the Mobile App* - Go to the Auto Show during the Entry Period and “check in” via the My SA – SuperAmerica mobile App, which can be downloaded for free at the iTunes and Google Play App Stores; or
2. *Visit the My SA Rewards® Booth at the Auto Show* - Visit the My SA Rewards® Booth at the Auto Show, during the Entry Period and complete and submit a Free Gas for a Year Auto Show Sweepstakes Entry Form; or

any technical or human error that may occur in the processing of submissions or downloading, that may limit, delay or prevent a participant's ability to participate in the Sweepstakes.

VII. SELECTION OF PRIZE WINNER: Two (2) Prize winners (collectively, "Winners"; individually, a "Winner") will be selected in a random drawing on or about March 31, 2018, from among the eligible entries received during the Entry Period. The odds of winning depend on the number of entries received. No participant may be awarded more than one Prize.

VIII. NOTIFICATION OF WINNERS & REQUIREMENTS: The Winners will be notified that he/she has won the Prize by email or telephone via the contact information provided in and/or associated with the entry. If (i) any Prize Winner does not acknowledge acceptance of a Prize within three (3) days after being notified that he or she is the Prize Winner and follow the instructions provided by Sponsor, including but not limited to the execution of an affidavit of eligibility and publicity and liability release, wherever lawful, or (ii) if the notification to a Winner is returned unclaimed or undeliverable, or (iii) a Winner if fails to claim the Prize at the time and date directed by Sponsor, an alternate winner will be chosen from the remaining valid entries using the procedure specified above.
